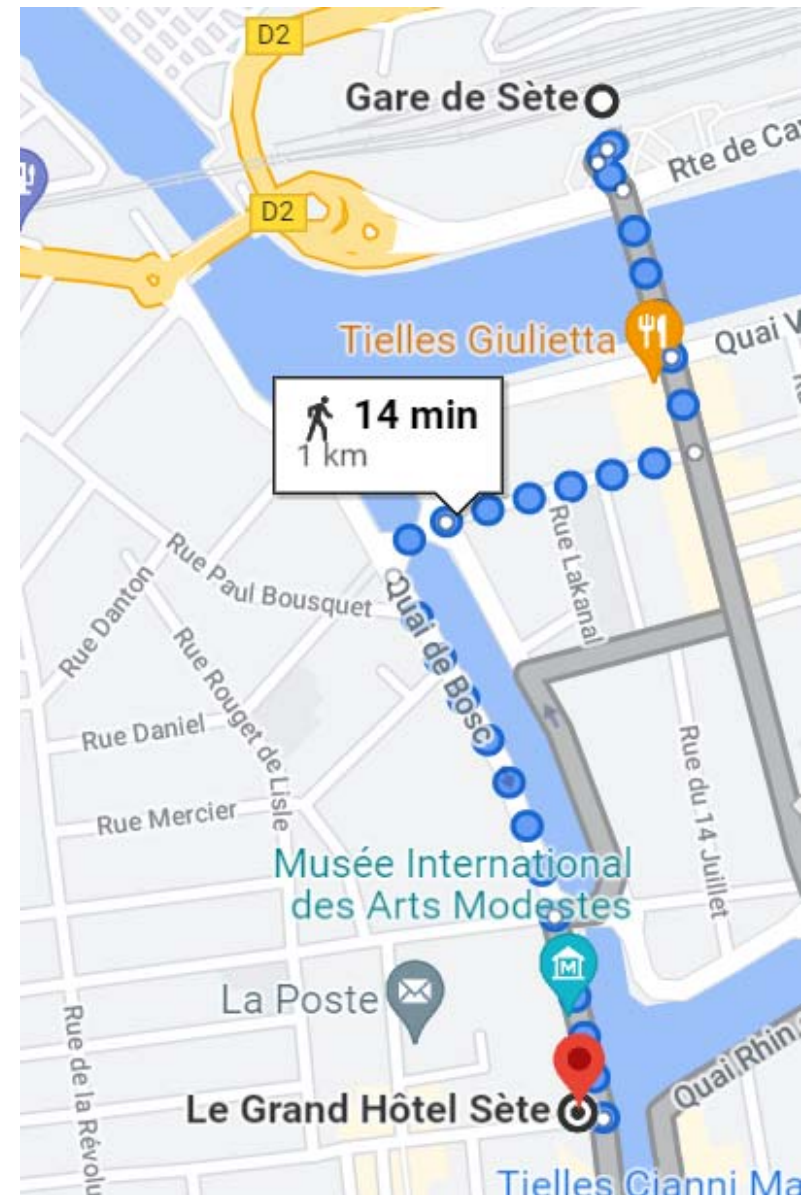
How to reach the Grand Hotel de Sète from Sète train station

How to reach the Grand Hotel de Sète from Montpellier Airport

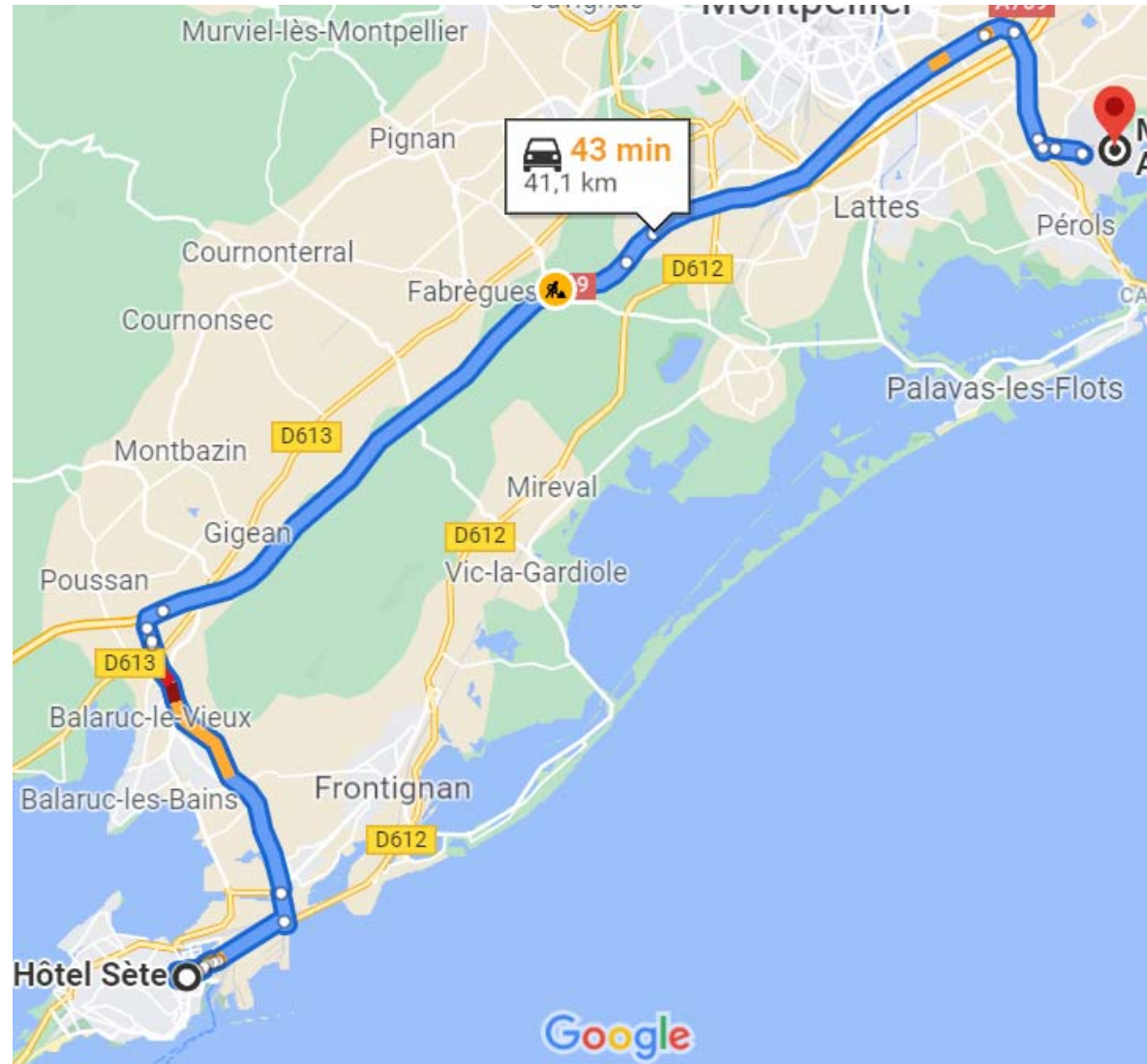
40 minutes from Montpellier Airport

Transfer Schedule

15 November

15: 45 → Shuttle from Montpellier Airport to the Grand Hotel Sète

13:00 → Shuttle from ‘Parlement de la Mer’ to Montpellier Airport

NB: Please make sure to have your **luggage with you** already on 16 November morning. The shuttle will leave after the tour of Port of Sète and will not stop by the Hotel.

COVID RULES

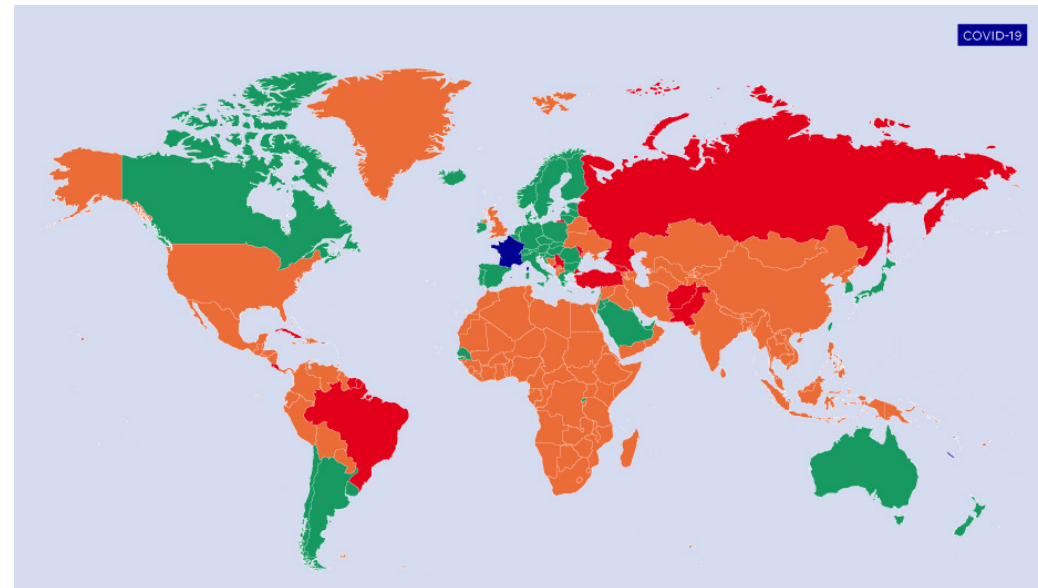
If you are coming from a **green zone**, no travel restrictions apply.
However, please be aware of the **sanitary check measures** in place:

- **Proof of vaccination**

or

- **PCR or antigenic test** done less than **48h** before entering France (For travellers coming from Bulgaria, Croatia, Estonia, Latvia, Lithuania, Romania, Slovakia and Slovenia, European countries under surveillance, a negative PCR or antigen test less than **24 hours** old is required)
