#### **Quality**

Electric Vehicles have been high on the agenda of ECG's Quality Working Group in the past years. One of the issues that the members flagged are the various requirements that OEMs have in terms of charging their Battery Electric Vehicles in the supply chain. Charge when? To what level? This is why ECG decided to survey the OEMs about the SoC with which their Battery Electric Vehicles (BEVs) leave the factories in Europe and with which they are transported.

Besides collecting the data for the OEMs, the <u>SoC table</u> contains also the requirements of the shipping lines who operate PCTC vessels as, following the publication of the <u>EMSA Guidance document</u> for the transport of Alternative Fuel Vehicles in Ro-Ro spaces, many shipping companies started to impose a maximum SoC level for the transported BEVs.

Obviously things will change over time, and we will plan to review the contents on a regular basis, but if you notice anything that is out of date or inaccurate do please let us know so we can update the information. This data is published for general information purposes and should not be relied on. Please check directly with the companies concerned if you need confirmation.

# **Sustainability**

On 17 July, ECG and Smart Freight Centre published the first ever methodology harmonising emissions accounting in the Ro-Ro segment. This is the result of a project which ran from February to July 2023 involving ECG Members operating Ro-Ro vessels.

The Ro-Ro methodology is in line with international standards such as <u>ISO 14083</u> and it provides, amongst others, a harmonised calculation approach for Ro-Ro operators.

It fits into the wider framework of the project ECG, VDA and other European OEMs like Jaguar Land Rover, Nissan and Toyota Motor Europe have been engaged in since February 2023, with the objective to define a standard methodology to calculate and report on automotive supply chain emissions.

Although the Ro-Ro publication came in July, it fits into the overall multimodal project aiming at harmonising automotive supply chain emissions calculation and reporting. The results of this are expected to be published later in the year in Q3 2023.

#### **EU Affairs**

On 11 July the European Commission published the Greening Freight package including two proposals which are relevant for ECG Members.

1. Weights and dimensions COM(2023) 445/2

ECG has been calling for harmonisation of loaded length of car transporters at EU level for many years. We are extremely happy that the European Commission has accepted our argument and included it in the proposal to revise the Weights & Dimensions Directive: a loaded length of 20.75 metres has been proposed with a maximum allowed overhang (0.5m in the front, 1.5m at the back) for car transporters.

2. CountEmissions EU COM(2023) 441/2

The European Commission proposed a new Regulation establishing rules for the accounting of greenhouse gas (GHG) emissions of transport services. The aim of this proposal is to create a single and reliable methodology used to calculate GHG emissions. The proposal covers freight and passenger transport operations.

The proposal is very much welcomed by ECG as we have an ongoing project on the same topic as described above in the Sustainability WG paragraph.
