ECG launched the <u>Tech Board</u> in 2023: a sort of think thank which has set forth to analyse the challenges the FVL industry is facing; to monitor the tech trends and to evaluate how the tech development can solve the challenges. The first step on the way was to launch a survey in December to the LSPs and OEMs to understand what challenges they are facing. The survey is now closed, we analysed the results and will soon publish them, along with some more concrete next steps.

Quality

We had the kick-off meeting of the used cars sub-group on 24 January and started the process of laying down the foundations of common recommendations for the handling and transporting of used vehicles. We have shipping lines, truck operators, maritime terminals and ports, as well as inspection and insurance companies participating so all processes will be covered in our discussions. It is still possible to join should anyone be interested. We plan to have bi-weekly calls to draft the manual which we will publish as an end result.

In the course of January, a <u>reporting form</u> on any fire incident with BEV or PHEV units was launched. We encourage our members to report via this form in case such an incident occurs. (We will keep it anonymous of course.) This way we will have a better understanding of what

is happening with these vehicles (whether they are new or used) in the supply chain. This initiative is about information sharing which can help us work for improving Quality and safety of operations.

The last Quality meeting attendees agreed to add the new chapter on the transport of cars in containers to the Operations Quality Manual. Version 10 of the manual was subsequently published in December. Please start using this manual which is already available in the original English language, as well as in French, German and Russian. The other translations are in the pipeline, while we are still waiting for a volunteer translator for Bulgarian. If you could help us with this language please reach out to me.

Sustainability

The first phase of the project on standardisation of emissions calculations and reporting from automotive supply chains finished in December 2023. The project produced the first standard methodology for automotive supply chain emissions calculation and reporting. The guidelines are available on ECG's website.

In 2024, there will be a second phase of the project looking at implementation. Project partners are discussing the set-up of this next phase.
