# **Digitalisation & ECG Tech Board**

A dedicated project on invoicing processes in Finished Vehicle Logistics was launched with around 20 interested members. We will look into the invoicing processes, analyse what issues our members have and understand what causes long payment times. As a later step the OEMs will also be included in the process as their input is equally necessary in order to work towards improved invoicing processes in the FVL sector.

The last meeting of the delivery at retailers subgroup was on 6 September. The group will present an escalation process to help resolve safety issues and also propose a legal clause at the Industry Meeting in Hamburg on 24 October. As a next step the process will be published and communicated to all ECG members who are operating trucks.

The latest Maritime & Ports meeting took place in Rostock, Germany on 26/27 September, kindly sponsored by Autolink Germany, Musco Lightning and Rostock Port.

On 26 September participants had the opportunity to meet in an informal environment during the networking dinner. The meeting took place on 27 September with a very engaging agenda and excellent speakers. Danique de Jonge, Senior Policy Advisor, European Sea Ports Organisation (ESPO) presented the latest study on port investment needs and main challenges for the European ports. ## Quality

September has been busy as the VDI Guideline on loading vehicle transporters was published at the beginning of the month. ECG knows that this is a challenge for our members, therefore we organised a webinar on 24 September, with the participation of the VDI and TÜV SÜD, who contributed to the creation of this updated version of the Guideline. Kässbohrer, Lohr, RIMO and Rolfo also spoke at the webinar and answered all the questions the participants had. Based on the questions received we are preparing an FAQ document for road transport operators.

We are glad to share the <u>recording of the webinar</u> with you in case you could not attend. We have also <u>published a press release</u> on this very important subject in which we emphasise that there should have been a transition period to permit vehicle logistics transportation companies to certify their trucks ahead of implementation. Now many thousands of trucks still need certification as, according to the trailer manufacturers, at the time of the webinar less than half of the trucks had received their certificate. Another bottleneck highlighted during the webinar was that of supply of the equipment needed to be compliant, such as new types of lashing belts. It is likely to take months before all certifications are issued and all trucks are equipped with the necessary lashing belts.

If your drivers encounter any issues during police inspections or at loading/unloading places please inform ECG about it.

Member States imposing road tolls on their national territories must follow the new requirements of the Directive.
